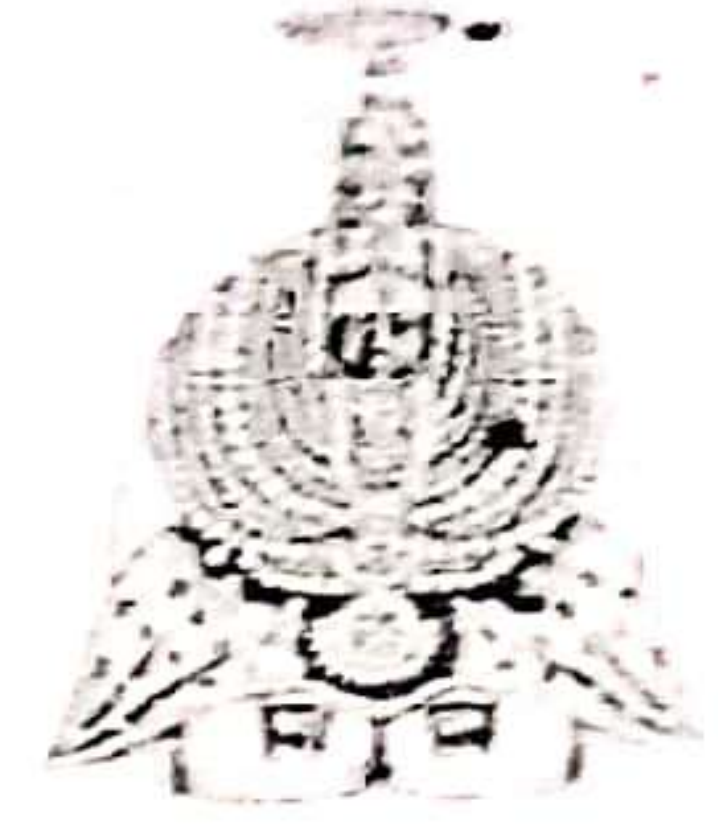

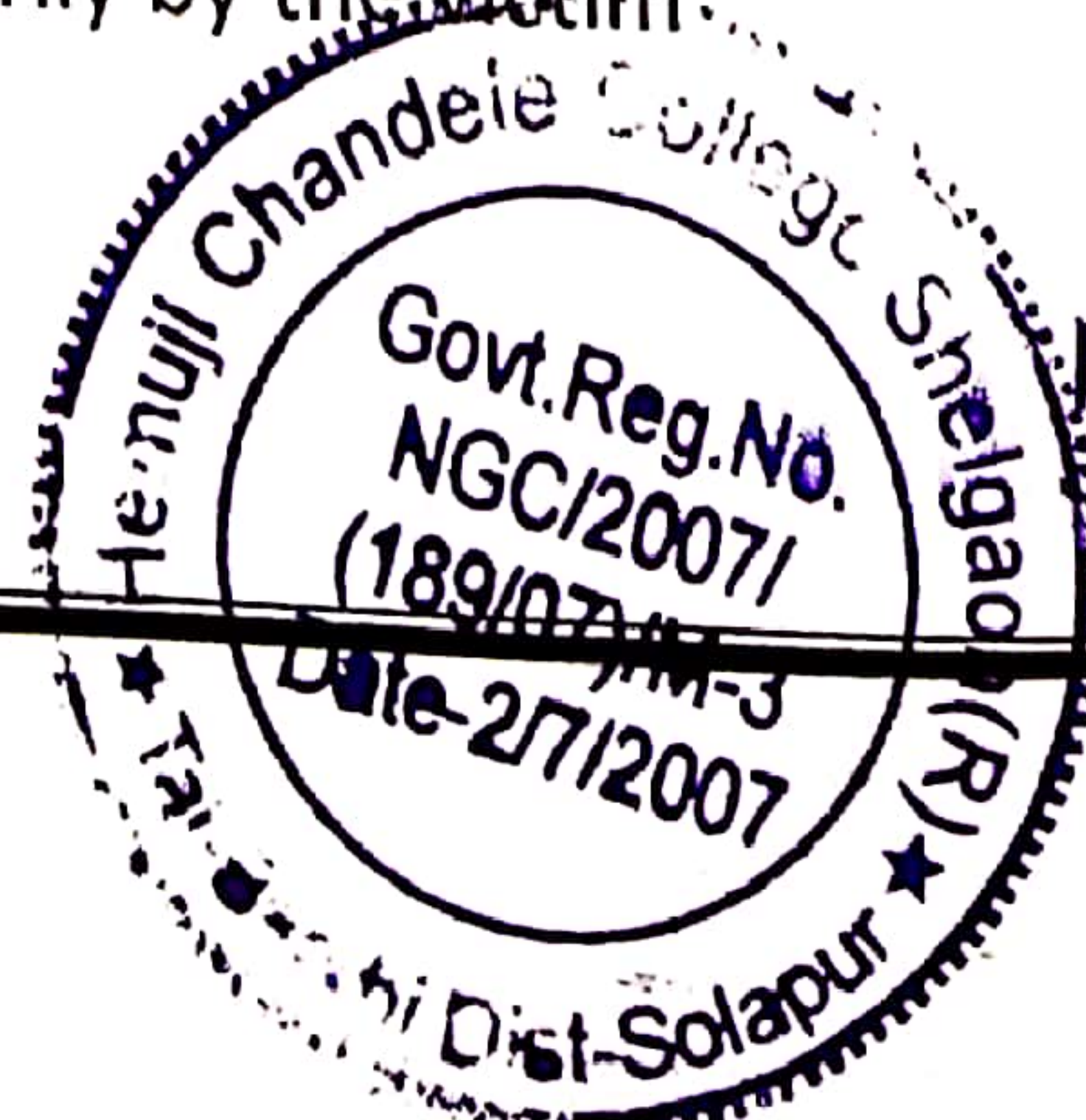
### How Ragging Happens

Rigging takes place by one or more of the following actions :-

- a) By words spoken or in writing or by any act done by any student or student any payment, which results in mockery of new students or any other students In doing, or behaving nobly, occurs .
- b) Bullying and indiscipline behavior by any student or students which any new a student causes harassment, distress, physical or mental harm to any other student Or causes or is likely to cause fear or panic There is
- c) Asking any student to do an act which he would not do in normal life, Which will cause embarrassment or torture or embarrassment which will have the opposite effect of new Will happen on the body or mind of the student or any student .
- d) Work done by any senior student which any other student or fresher A student's regular academic activities will be interrupted, prevented or disrupted
- e) Academic work assigned to a student or group of students, new students or  
Extorting students by asking them to complete
- f) Extortion of money by the student from new students or other students or  
Financial burden
- g) Any physical abuse, including all its different forms: sexual abuse, Homosexual assault Undressing, forced intercourse and sexual acts, sexual dismemberment, Acts which cause any bodily harm or any other danger to health or person
- h) Active or passive in fear of causing trouble to freshmen or any other students Any action taken in the form of, or, uttering abusive language, sending by e-mail, post, Humiliating in public, deriving perverse pleasure from doing so, or by harassing others Or involve the pursuit of supernatural thrills

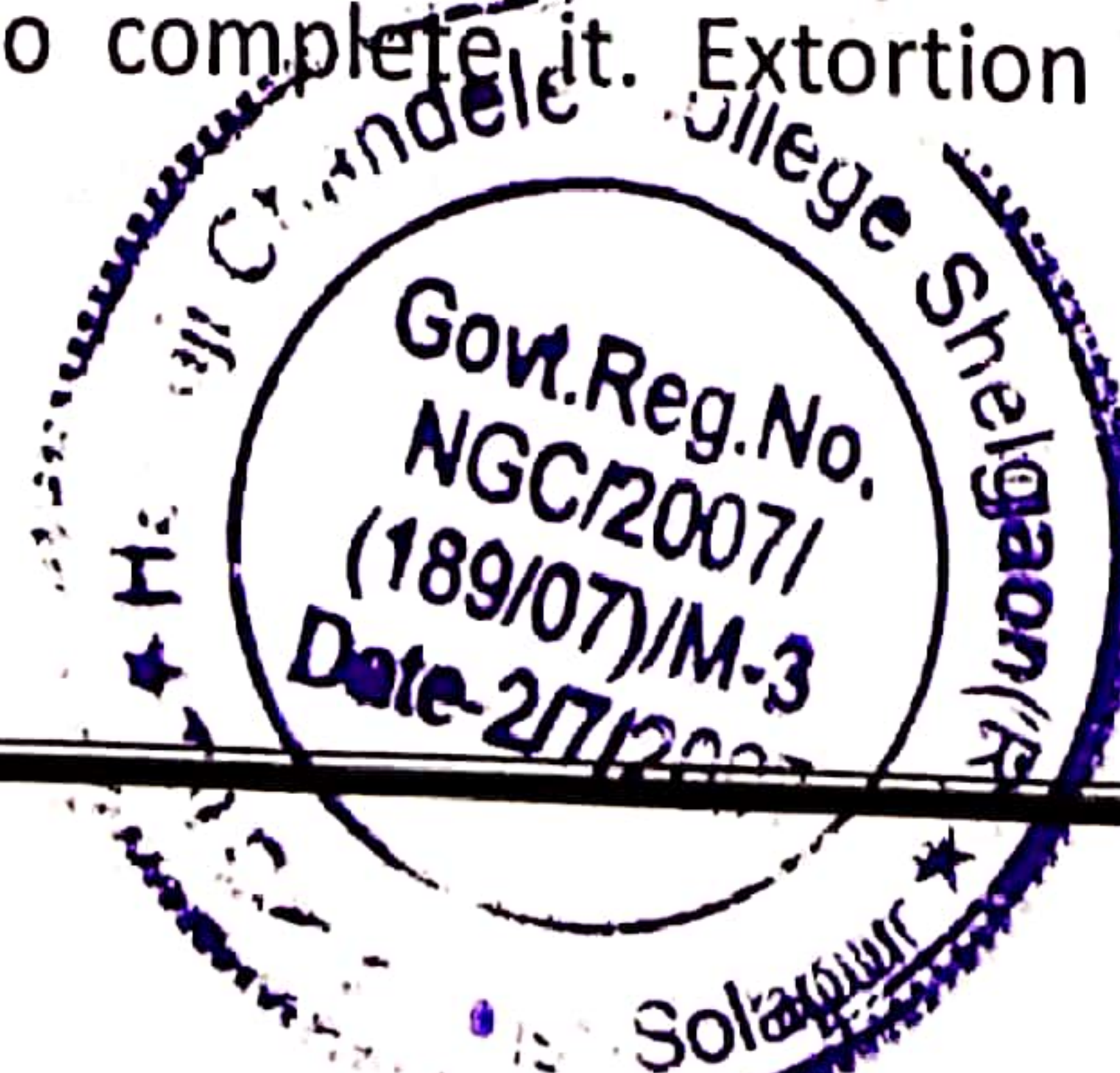

### Summary of University Grants Regulations to Reduce Ragging in Higher Education Institutions, 2009.

1. Introduction: Dated 08/05/2009 Hon. Taking into account the resolution of the Central Government and the University in view of the direction given by the Supreme Court, it was allowed to implement ban, prevention and eradication of the menace of ragging.
2. Objective: To eradicate all forms of ragging from the Universities, Deemed (Deemed) Universities and other higher educational institutions of the country, prohibiting ragging under these Regulations, as well as preventing the same from occurring and punishing the persons involved in ragging under the regulations made in this regard and in accordance with applicable laws
3. What causes Ragging: Ragging occurs by one or more of the following acts:
  - A) Any behavior by any student or students by words or in writing or by action, which results in making fun of, mocking, or behaving rudely towards a fresher or any other student.
  - B) Bullying and disorderly conduct by any student or students which causes or is likely to cause distress, physical, mental injury or fear or intimidation to any new student or any other students.
  - C) Asking any student to do an act which he would not do in normal life, which would cause embarrassment or torture or embarrassment which would adversely affect the body or mind of the new student or any student.
  - D) Acts by any senior student which will disrupt, hinder or disrupt the regular academic activities of any other student or fresher.
  - E) Academic work assigned to a student or group of students New students
  - F) Or extorting other students by asking them to complete it. Extortion or financial burden by students from new students or other students.

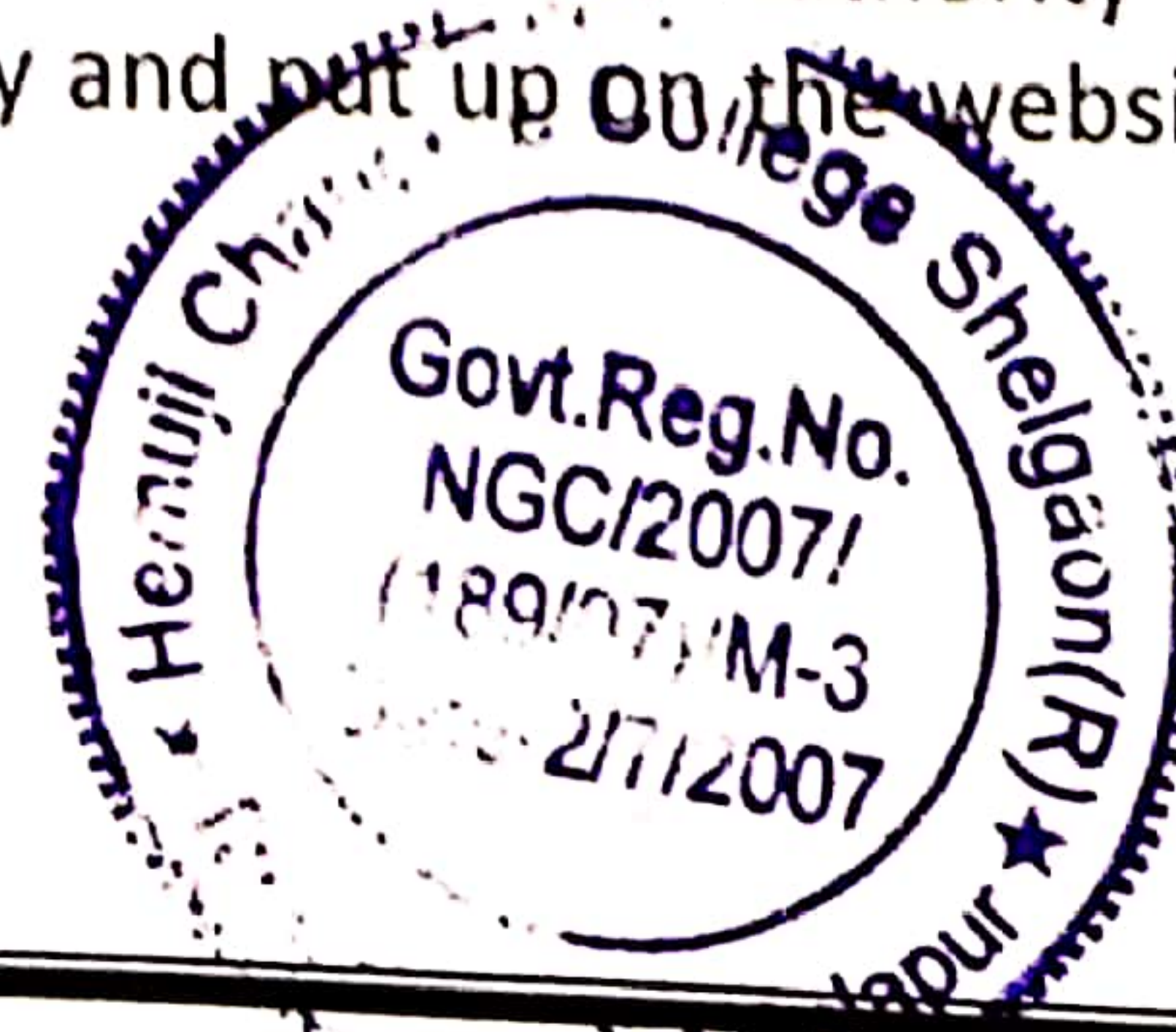
- G) Any physical abuse, including its different forms: sexual abuse, homosexual assault, undressing, forced sexual and sexual acts, sexual mutilation, causing any physical harm to health or person or any other danger.
- H) Debarment for any test/examination or other assessment process.
- D) Withholding results.
- E) Refusal to represent the Institute in any regional, national or international meet, sports session, youth festival etc.,
- F) Suspension/Expulsion from Hostel
- G) Cancellation of Access.
- H) Removal from the Institute for a period of one to four sessions.
- I) Exclusion from the institution for a specified period and also denial of admission to any other institution.

If the person committing or encouraging the act of ragging is not identified, the organization will resort to collective punishment:

An appeal shall lie against the order of punishment passed by the Anti-Ragging Committee, (i) in the case of an order of an institution affiliated to or a constituent part of the University, the University

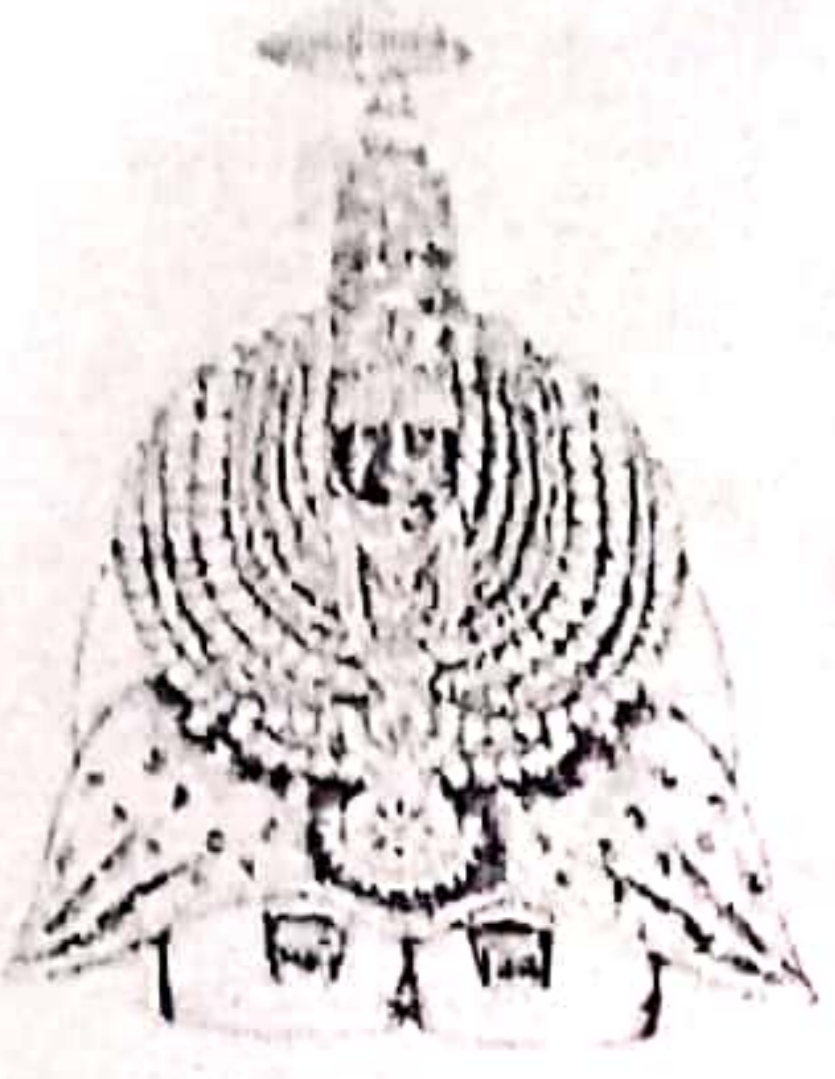
To the Vice-Chancellor; (ii) in the case of a University mandate, to its Chancellor. (iii) in the case of an institution of national importance created under an Act of Parliament, to the Vice-Chancellor or Chancellor of the institution, as the case may be.

4. In the case of issuing notices or taking appropriate action to arrest incidents of ragging or who show apathetic, callous attitude towards complaints of ragging, or who fail to take timely steps, if required in these regulations or otherwise to prevent incident or incidents of ragging, when in the opinion of the Appointing Authority, if the misconduct is attributable to any member of the faculty or staff of the institution, departmental disciplinary action against the member of the faculty or staff shall be initiated by such officer in accordance with the prescribed procedure of the institution. When such misconduct is related to the head of the institution, departmental disciplinary proceedings shall be instituted by the authority appointed to appoint such head, and such proceedings shall be for failure to take appropriate steps to prevent ragging or to punish the student found guilty of ragging. This shall be without prejudice to the proceedings which may be taken in the matter Central Officer of the affiliated University, concerned District Authority if necessary, and District Magistrate, Superintendent of Police if necessary and put up on the website to be in public domain and also viewable by media and citizens.

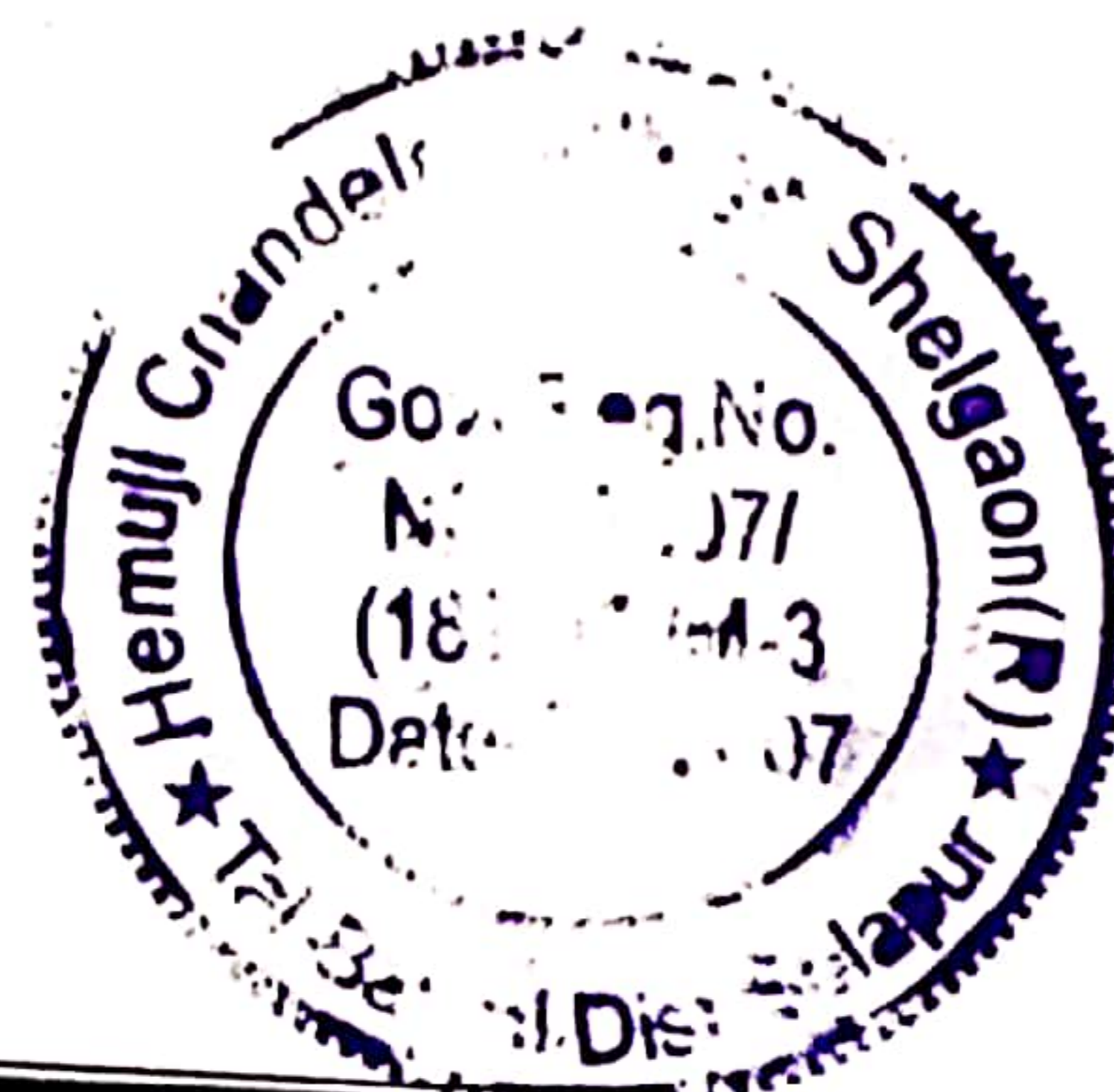

5. On receipt of the recommendation of the Anti-Ragging Squad or of any reported incident of ragging, the Head of the Institution shall immediately determine the matter to be dealt with under the Penal Code, and, if so desired, by himself or by the members of the Committee .officially appointed by him to do so on his behalf, such information or within twenty-four hours of receiving the referral ,along with the police and local authorities, under appropriate penal provision, take steps to register a preliminary information report.
6. The Commission shall maintain a reasonable data base of the affidavits declared by the student and his/her parents/guardians and store the same electronically either by the institution itself or through an agency appointed by it, and such data base shall be kept of the complaints of ragging received, and the action taken thereon. Will act as a status record.
7. Any incident of ragging in the institution will adversely affect its accreditation, numbering or grading when assessed for the purpose of accreditation, numbering or grading by the National Assessment, and Accreditation Council or any other official accrediting agency.
8. Institutions which are otherwise eligible for grant under Section 12B of the Act, having a clean record of no incident of ragging, may be given priority in financial assistance by the Commission.
9. Administrative Proceedings in Incidents of Ragging: Students guilty of ragging shall be punished following the procedure laid down by the institution and in the prescribed manner:
10. The Anti-Ragging Committee of the Institute shall take a reasonable decision on punishment or any other matter depending on the facts of each incident of ragging determined by the Anti-Ragging Squad and the nature and seriousness of the incident of ragging.
11. Depending on the type and seriousness of the offense determined by the Anti-Ragging Squad, the Anti-Ragging Committee may impose one or more of the following punishments on those found guilty, namely;
  - A) Suspension from class attendance and academic privileges.
  - B) Withholding/withdrawal of scholarship/scholarship and other benefits.
